

DJ Commodity Index: Daily: Downside correction?



- If Bulls' case perseveres, look for corrective retracement Support areas, eg, Gann angle Support lines & Fibonacci Retracement Zone itself (including *extended 76%* level), to halt declines, forming complex bottom. See accompanying Weekly.
- Bears contend secular downtrend still valid, and recent consolidation will prove temporary.
